

Announcement – Call for Interest: Individual Trainers for Project Management

Delivery of Results-Oriented Project Management Courses for AIZ Bangkok

Results-oriented Project Management (face-to-face course)

The interested candidates should include ALL training products in their offer.

Core Responsibilities:

For each of the training product, the successful candidate is expected to

- Study the training plan and materials and adjust/adapt them to be suitable for each training course.
- Conduct learner/participant analysis where appropriate
- Prepare/finalize training agenda, training materials, moderation/facilitation plan and coordinate with AIZ Bangkok for finalization.
- In case there is a co-trainer provided by AIZ Bangkok, coordinate with co-trainer for preparation and delegation of roles/responsibility. The consultant/trainer shall take the leading responsibility of the overall training.
- Prepare/finalize the training setting at the training location
- Adjust training plan, materials, and relevant documents according to real implementation after each individual course
- Provide advice on training quality and didactic approach as required

Qualification:

Possess more than 10 years of experience as trainer on the training topics they are
proposing for e.g. "management" and/or "multi-stakeholder facilitation" and has
experiences implementing high quality training courses in the portfolio of their choice
listed above



- Have proven experience and in-depth knowledge/understanding of results-based management system used by development partners such as the EU, the World Bank, GIZ, and USAID with good understanding on general context of development cooperation projects in Asia with more than 10 years of professional experiences in the field.
- Have been working in the field of sustainable development or international cooperation for more than 10 years
- Has more than 10 years of experience as project staff, consultant, facilitator or coach for project activities in the field of project management/implementation in international/development context
- Have experiences in organizational capacity development and able to facilitate
 improvement of RBM system in an organization/project/programme. He/she must have
 experiences in designing or adjusting the training concept/curricula according to
 the capacity development need and change objectives in different development topics
 e.g. Climate Change, Environment, Energy
- Have in-depth understanding and experiences in applying good learning didactic and suitable adult learning principles. He/she should be able to facilitate learning through discussion, dialogue, reflection, practices and other appropriate methods/tools according to AIZ training approach under 2.2 and able to handle challenges during training and handle them professionally
- Speak, read and write English and/or Thai fluently at the level of near native speaker, and is able to conduct training in English and/or Thai very fluently. For courses, conducted in English, the candidates should be familiar with English communication in Asian context and different accents of English communication in Asia. Being able to deliver the training in German or other Asian languages is an asset.
- Possess excellent communication and inter-personal skills, especially with Asian and German context.

This will be an assignment-based contract, starting as soon as possible and running until March 2026 with possibility to extend. Training schedule will be discussed at a later stage between successful candidates and AIZ Bangkok
