Gender Experts Supporting the AMUSE Project: Developing Gender-Sensitive Tools and Enhancing Stakeholder Capacity for Gender-Sensitive Waste Management in the Tourism Sector

The ASEAN region is one of the fastest-growing regions in the world with high population growth and rapid urbanization. Cities and municipalities lack the resources and capacity to ensure clean air and land, as well as basic supplies in the water, waste, and energy sectors, although these areas are the key to a good quality urban environment and services of general interest. In 2016, the volume of waste generated in Southeast Asia reached around 150 million tonnes which is one of the big challenges and critical problems the region is facing. It is estimated that waste generation will increase by 150 percent in 2025 compared to 1995 levels unless it is counteracted.

In addition, the importance of tourism as a relevant economic factor is growing. Between 2000 and 2018, tourism numbers (international arrivals) tripled in the East Asia and Pacific region. This is accompanied by growing amounts of waste. Small and medium-sized cities, in contrast to the large urban centers of ASEAN countries, are facing considerable difficulties in dealing with growing waste volumes due to population growth, changing consumption patterns, and increasing tourism numbers. Municipal administrations do not have the necessary technical and management competencies to adequately manage the steadily increasing waste volumes due to population patterns, and growing tourism, as well as to involve private sector actors in waste management and resource-efficient solution approaches.

The AMUSE Project operates in countries such as Cambodia, Laos PDR, Thailand and Vietnam. For AMUSE Project Thailand, it operates through a Project Management Unit (PMU), comprising the Pollution Control Department (PCD), the Department of Climate Change and Environment (DCCE), and the Department of Tourism (DOT). The AMUSE PMU aims to strategically guide and advance relevant policies on waste management in the tourism sector, as well as build the capacity of relevant public and private sectors to effectively implement waste management in tourist sites in medium-sized cities in Thailand.

Gender-sensitive waste management in the tourism sector is a crucial part of the AMUSE Project. However, PMU members and model cities still lack an understanding of gender sensitivity, especially in municipal solid waste management and tourism management. Therefore, it is necessary to enhance the understanding of both PMU members and model cities from the waste management sector and tourism sector regarding the implementation of gender sensitivity. In this regard, the project would like to hire a consultant (Legal entity – Company/ Organization/ University/ Institute) to develop three gender-sensitive instruments in relation to waste management in tourism sector and to be instructor(s) and one training delivery for target audiences at policy and operational levels. In addition, the consultant shall collaborate with the AMUSE Project and PMU members to plan for the training design and process.

Description of Assignment:

The AMUSE project is looking for a consultant team to provide consultancy services in gender-sensitive waste management in the tourism sector and capacity development. The consultant team is responsible for completing the following tasks.

- 1. Development of three gender-sensitive instruments
- 2. Being instructors on gender-sensitive instruments training for target audiences at policy and operational levels

The consultancy is expected to provide **a list of experts** who will work on this assignment. The consultancy should demonstrate the team of experts fulfills all the below-mentioned qualifications and skills:
